Questions / **Answers**

1. It appears that Line 838-857 on the Howard County list are duplicates of lines 818-837. Should these lines be removed? **The lines have been mistakenly duplicated Lines 838-857 have been deleted in the revised Bid Form A.**
2. The item numbers below are not a valid numbers on the Boundtree website- we need a correct # to know what they are requesting
 - a) Line #22 -A36624 **Deleted**
 - b) Line #150- 291870 **Correct Number 1031-87010**
 - c) Line #151- 291551 **Correct Mfg. Precept with Number 15510**

- d) Line #185- 380453 **Correct Number 380038**

- f) Line #199- 2711-65014 **Correct Mfg. Covidien Number DS100A-1**
- g) Line #201- A869124 **Correct Number 172786**

- j) Line #229- **Delete**
- k) Line #230- **Delete**

3. Lines 163-171 are listed as discontinued. Can we list the correct replacements for these on Bid Form A or will they need to be listed on the exception form? And Line #251- Pro4000 has been discontinued, replaced with PRO6000. Does this have to be listed on the exception form?

The list has been copied to revised Bid Form B (Exceptions) list. Please list any discontinued items on the Bid Form B (Exceptions).

Any other items that are found to be discontinued should be done in this fashion keeping the same Item number from Bid Form A but putting info for the substituted item (exception) in the spreadsheet columns on the Bid Form B (Exceptions) form.

4. Line #271- 20 drop set- need more information, mfg #, type of sites, length, etc **Medex SM872 (see weblink on revised Bid Form A).**
5. Line #369- prep razors- need mfg. / part # **Medchoice / RZR2000**
6. There are several items listed on the Charles County list that shows MedStorm as the manufacturer. This is no longer a valid manufacturer. Can we submit on Bid Form A our item or do they all need to be listed on the exception form? This would be an extreme amount of items that would have to be listed on the exception form.
