### 3. UPDATE ON THE MDOT SHA PEDESTRIAN SAFETY ACTION PLAN (15 MIN)

Ms. Kandese Holford, MDOT SHA, and Ms. Deni Deliallisi, MDOT SHA consultant, will provide a status update on the Pedestrian Safety Action Plan (PSAP), including progress to date and remaining steps to finalize the plan. Through the PSAP, MDOT SHA will work with communities to improve pedestrian safety by identifying challenges, setting goals and objectives, focusing on areas of need, setting priorities, and taking action. The PSAP also will leverage MDOT SHA's responsibility for engineering and evaluation of the MDOT SHA transportation network. This focus will complement existing pedestrian safety programs overseen by MDOT to harness the collective benefit of the 4 E's: Enforcement, Engineering, Education, and Emergency Medical Services. The plan's ultimate goal is to reduce traffic-related serious injuries and fatalities on Maryland's roads.

#### 4. BALTIMORE CITY MICROMOBILITY PROGRAM (15 MIN)

Ms. Meg Young will share information about Baltimore City's Dockless vehicle or micromobility program which includes e-bicycles and e-scooters. The dockless vehicle program in Baltimore City launched in 2019 with a pilot initiative preceding in 2018. Dockless scooters and bikes are equipped with GPS technology so they can be easily located, rented, and parked through a smart-phone app or text-to-unlock plan. Baltimore City Department of Transportation (BCDOT) has also implemented a parking corral program by designating parking spots for dockless vehicles across the city where riders who use them can receive discounts for courteous parking. In Baltimore City, an average of 120,000 trips are taken with dockless vehicles each month. More than 5 million trips have been taken with dockless vehicles since late 2018, with many replacing rides which would have been taken in motor vehicles.
