Mr. Andrew Mengel, Department of Natural Resources (DNR), will share information about the Land Preservation and Recreation Plan (LPRP) which is updated every five years. The Plan identifies essential issues impacting outdoor recreation and natural resource protection in Maryland. The Plan was developed using public input gathered through surveys, stakeholder meetings and through analysis of national, state, and local issues impacting recreation and natural resource conservation. The Plan serves as Maryland's Statewide Comprehensive Outdoor Recreation Plan and qualifies the state to receive funding through the federal Land and Water Conservation Fund.
- 4. PRESENTATION: WALKTOBER AND WALK MARYLAND DAY 2022 (15 MIN)**

Ms. Francine Waters, Maryland Department of Transportation the Secretary's Office (MDOT TSO), will share information about Maryland's annual WALKTOBER, a month long campaign in October where MDOT and other partnering agencies promote and host events and webinars spotlighting pedestrian safety, health, and commuting options. Ms. Waters will also share information about Walk Maryland Day which is a celebration of Maryland's official exercise and a call to action to support safe walking and walkability. Maryland residents are invited to register and commit to walking on October 5th.
