3. RECOMMENDED ACTION OF RESOLUTION #18-5

The TC will be asked for its recommendation on Resolution #18-5 involving the Maryland State Highway Administration's request for an amendment to the FY 2018-2021 Transportation Improvement Program. SHA wishes to add a project to improve drainage on I-695 at Cromwell Bridge Road. The total estimated project cost is \$13.45 million (\$10.76 million in federal funds and \$2.69 million in matching funds) for preliminary engineering, right of way, and construction.
