2. RECOMMENDED ACTION ON RESOLUTION #18-10

The TC will be asked for its recommendation on Resolution #18-10. This involves adding a project to the 2015 Regional Transportation Plan, known as *Maximize2040*, and the FY 2018-2021 Transportation Improvement Program (TIP) as well as the associated air quality conformity determination. This project, sponsored by the Maryland Transportation Authority, proposes to use the design-build project delivery approach to extend express toll lanes northbound on Section 200 of I-95.

3. RECOMMENDED ACTION ON RESOLUTION #18-11

The TC will be asked for its recommendation on Resolution #18-11. This involves adding a project to *Maximize2040* and the FY 2018-2021 TIP as well as the associated air quality conformity determination. This project, sponsored by the Maryland State Highway Administration, proposes to use the design-build project delivery approach to implement an Active Traffic Management project on I-695 from I-70 to MD 43, involving use of the inside shoulders for the a.m. and p.m. peak periods.

4. RECOMMENDED ACTION ON RESOLUTION #18-12

The TC will be asked for its recommendation on Resolution #18-12 to adjust funding for two projects currently in the FY2018-2021 TIP. This involves:

- adding federal funds for construction and state funding for preliminary engineering for the I-83 bridge replacement over Padonia Road
- switching federal funding sources and updating preliminary engineering, right of way, and construction funds for U.S. 40 bridge replacements over Little and Big Gunpowder Falls.
