## **MINUTES**

# 1. WELCOME AND SELF-INTRODUCTIONS

Mr. J.J. Lynott, Chair, welcomed attendees and attendees introduced themselves.

# 2. REVIEW OF MINUTES FROM MARCH 1, 2023

There were no comments on the minutes.

#### 3. STATE AND LOCAL TIM UPDATES

- TIM Training updates:
  - Mr. Kevin Fox is the new Training Manager at MDOT SHA.
  - Number trained in Maryland as of July 17, 2023, is increasing slowly, up to 42.5% equating to 9,862 responders.
  - In response to a question about where the total number of responders to be trained came from, Mr. Breck Jeffers responded that he met with Ms. Eileen Singleton and Mr. Scott Yinger (formerly with MDOT SHA) in about 2014 when the training was being rolled out. They looked at job categories from the Bureau of Labor Statistics and identified responder categories, then estimated the portion of responders that would be TIM responders. Each state calculated their own total number of responders to be trained. It was noted that volunteer firefighters are not included in the BLS categories and the total responder number is almost 10 years old. However, the total is used as a target; there is no funding tied to percent trained. Another note about the responder number is that in Maryland, most EMS responders are also Fire so while the data shows only 15% of EMS responders have been trained, other EMS responders may be listed under Fire.
  - o It is unknown if Train-the-Trainer courses are coming up.
  - Training is not required for towers. To require it may require changing legislation.
- State TIM Update:
  - The MSP TIM unit have been in place since July 2021.

Mr. Lynott offered the suggestion to work through a portion of the self-assessment at each meeting rather than all at one time. No decisions have been made about this approach.

The self-assessment scores are submitted to the FHWA, and FHWA compiles the scores from all metropolitan areas to assess the whole country; scores for individual areas are not shared.
