- Enhanced Mobility of Seniors & Individuals with Disabilities Program
- Two-Year Funding Cycle
- Two Types of Funding
 - Capital (80/20 match)
 - Operating (50/50 match)
- Two Review Processes
 - Rural or Small Urban
 - BRTB Endorse/Not Endorse
 - SCCHST Approve/Amend/Deny
 - Large Urban
 - BRTB Approve/Amend/Deny





Section 5310 Program: Criteria



- Extent and Urgency of Local Needs (10 points)
- Coordination and Cooperation (20 points)
- Vehicle Utilization (10 points)
- Fiscal and Managerial Capability (10 points)

Rural or Small Urban: Staff Comments

The Arc of Carroll County, Inc.

- 4 Replacement Vehicles Light Duty Small Bus (8x2)
 - The minimum service-life for a light duty small bus established by MTA is 5 years and 150,000 miles.
 - The four vehicles to be replaced will exceed 150,000 miles in this grant cycle and three will exceed 200,000 miles, with the highest at 249,000 miles.
 - In addition, all four vehicles will be over 9 years old, with 18 years being the highest.
- 1 Expansion Vehicle Side Accessible Minivan
 - The expansion vehicle will enable The Arc to fulfill the Federal mandate to provide more community-based and individualized services to its clients.
