### **Shipping Essential Goods**


- Municipal waste

- Norfolk Southern has an effective pandemic response plan in place
- Daily calls between railroads
- Constant communications with federal and state governments



#### Industry Response and Precautions

- Providing timely and accurate information
- Limiting possible exposure
- Expanding frequency of cleaning and sanitation
- Limiting group settings
- Restricting access to mission-critical work spaces
- Social distancing
- Transitioning employees to telework when possible
- Adhering to CDC guidelines



#### Norfolk Southern's Updated Hygiene Policies

- New cleaning and disinfecting guidelines in accordance with CDC recommendations for NS workspaces – shop, crew room, office desk, locomotive cab
- Secured necessary supplies to support enhanced cleaning and safety of employees – hand sanitizer, alcohol wipes, EPA-approved disinfectant cleaners
- Audits of NS' janitorial service contractors, site visits, spot checks to assess conditions and ensure product and cleaning protocols are being followed
- Coordinated efforts with our PTI taxi service and MSI lodging contractors to ensure they have cleaning supplies required





# Relief for Rail Workers Affected by COVID-19

- Railroaders receive unemployment benefits through the Railroad Retirement Board (RRB) Railroad Unemployment Insurance Program (RUI)
- The COVID-19 stimulus package includes:
  - Waives the 7-day waiting period for filing sickness or unemployment claim with RRB
  - Increases unemployment benefits through additional \$1,200 bi-weekly benefit
  - Allows RRB to access \$130 million of remaining American Recovery Reinvestment Act to provide extended benefits through December 31, 2020



## Maryland COVID-19 Response



- Freight rail transportation has been classified as "essential" under Hogan's executive order
- NS has been working with state and local officials to ensure that employees continue to have access to job sites
- Complying with state-enacted legislation to ensure that our employees remain safe during COVID-19
