As the Maryland Department of Transportation (MDOT) Secretary, I am writing today to ask for your help in alleviating a threat faced by all Maryland citizens. Motor vehicle crashes remain one of the most prevalent causes of death and serious injury during a person's lifetime. Death or injury is never an acceptable consequence of driving our highways, and frankly, none of us are spared that risk. It is truly a very personal issue to me.

Despite significant progress in the prior decade when our State experienced significant declines in fatal and serious injury crashes, we will not be satisfied until those numbers sit squarely at zero. Even with a 70-year low in the number of fatalities in 2014 (443), we should never consider the needless loss of life on Maryland roads is a "good year." Worse yet, like most of the country, the number of traffic-related fatalities and serious injuries on Maryland roads has begun to climb during the past two years. This is simply unacceptable.








Anticipated (Aggressive) Timeline
