

## New Residential Permits State





#### Permitted New Residential Units in the Baltimore Region, 2007 - 2016









Rendering of New Hotel & Restaurant at Casino Live (below)




#### Major New Non-Residential Projects

- \$24.5million: 4-Story Assisted-Living Building






