

## What We Do - BRTB

- Two-year work program (UPWP)
- Short-term transportation program (TIP)
- Long-range transportation plan (Maximize 2040)
- Air quality assessments of all transportation projects







# What is the Transportation Improvement Program (TIP)

- Short-range (four-year) program of transportation improvements & priority projects
- Financially constrained
- Authorizes project sponsor to seek or use federal funds
- Generally updated annually
  - Current TIP is FY 2018-2021
- Amendments require 30-day public review
  - New projects, new funding, etc.





# **Air Quality Assessment**

 The TIP goes through a process that compares estimated pollutants (emissions) from transportation projects to limits (budgets) set by the state.



This report, called a "conformity determination", addresses the 8-hour ozone standard.





### BRTB SET TO VOTE / NOV 28

:: Hawkins Point Bridge over CSX Railroad Project























- This project is a part of the Baltimore City Department of Transportation's long—range transportation planning goal of improving and maintaining existing infrastructure.
- The project is for the full replacement of the bridge over the CSX railroad and will include:
  - Providing increased structural and traffic safety
  - ADA compliance
  - Landscaping





- This amendment adds the project to the 2018-2021 TIP utilizing National Highway Performance Program (NHPP) funds.
- The project had been in the FY 2017-2020 TIP but due to unforeseen delays in the approval process to advertise did not move forward.
- Therefore the project needs to be re-entered into the FY 2018-2021 TIP to obligate funds.
- The project allocates construction funds in FY 2018 totaling \$22 million.
  - \$17.6 million in federal NHPP funds
  - \$4.4 million in local matching funds.





This amendment proposes to add this project to the 2018-2021 TIP with the following funds:
