
# PROJECT DESCRIPTION

- US 1 / I-95 / MD 175 technology corridor to pilot innovative connected vehicle applications
- Messaging will occur over two separate deployments:
  - traffic signal data to approaching vehicles with associated lane / approach information (Signal Phase and Timing - SPaT)
  - Origin-Destination messaging during incident conditions (or other major events)
- Dual-mode units (DSRC and CV2X compatible)
- Messaging will be secured through our statewide <u>SCMS platform</u>
- SHA purchased OBUs (on-board units) to test receiving messages. Actual data streams are public so messages can be received by anyone who has the appropriate OBU.
- Schedule: currently being deployed!

# SPat DEPLOYMENT LOCATIONS




