#### ADDENDUM NO. 1

THIS ADDENDUM entered into this <u>17th</u> day of <u>June</u> 2025 by and between HARFORD COUNTY, MARYLAND, a body corporate and politic of the State of Maryland, hereinafter referred to as the "County", and **BRENNTAG NORTHEAST, LLC, 81 W. Huller Lane, Reading, Pennsylvania 19605,** hereinafter referred to as the "Contractor.

**WHEREAS**, on October 24, 2024, the County and the Contractor entered into an Agreement to provide bulk chemicals for water and wastewater treatment ("Agreement"); and

WHEREAS, the Agreement expires on June 30, 2025; and

WHEREAS, the County wishes to extend the term of the Agreement; and

WHEREAS, the County wishes to add a Section to the Agreement; and

**WHEREAS**, the Contractor submitted a letter dated April 24, 2025 proposing new pricing, which is attached as Exhibit 1 and incorporated herein.

**NOW, THEREFORE**, in consideration of the mutual promises and covenants contained herein, the recitals which are incorporated by reference herein, and other good and valuable consideration, the receipt and adequacy of which is acknowledged, the County and the Contractor, intending to be legally bound, agree to amend the Agreement as follows:

- 1. The first option year option year is exercised, extending the term of the Agreement from July 1, 2025, to June 30, 2026.
- 2. Effective on the fully executed date of this Agreement, the following Section is added to the Agreement:

#### **SECTION XIX: TARIFFS**

Should any items increase in price due to the imposition of a tariff, after the renewal date of this Agreement the Contractor may submit in writing to the County, a request for tariff adjustment that includes the item(s), the

agreement cost of the items(s), and the amount of the increase due to the tariff. The Contractor shall also provide documentation showing the increase in price paid by the Contractor due to the tariff. Where the requested increase is, in the sole opinion of the County, significant, the County reserves the right to procure the item(s) from an alternative source offering a price at least ten percent (10%) below the requested price, if the tariff on an item returns to its pre-request level, the unit price in place prior to the tariff request shall be reinstated.

- 3. The pricing in Exhibit 1 shall become effective on July 1, 2025.
- 4. The person executing this Addendum on behalf of Contractor represents, warrants and affirms, under penalty of perjury, that he/she has the authority to bind Contractor to this Addendum.
- 5. Except as specifically provided herein, the terms and conditions of the Agreement shall remain in full force and effect.


