

**CONTRACT ADDENDUM #2**  
**Airport Self Pay Vending**

This Addendum (the "Addendum") is made and entered into as of March 11, 2025 by and between:

1. **Daniels Vending LLC** a limited liability company with its principal office located at 5620 Landing Neck Rd, Trappe, MD 21673 ("Vendor");

and

2. **Wicomico County** a government entity with its principal office located at 125 N. Division Street, Salisbury, MD 21801 ("Company").

**WHEREAS**, Vendor and Company entered into a contract dated February 8, 2024 (the "Original Contract"); and

**WHEREAS**, the Vendor has been acquired by **CRH Catering Co. Inc.** (the "Original Acquirer"), effective as of October 16, 2024 and

**WHEREAS**, the Original Acquirer has been acquired by **Sodexo Operations LLC.** (the "Second Acquirer"), effective as of January 02, 2025 and

**WHEREAS**, the parties wish to amend the Original Contract to reflect the acquisitions and to ensure that the terms of the Original Contract remain binding and enforceable in light of the change in ownership.

Now, therefore, the parties agree as follows:

**1. Acknowledgment of First Acquisition**

The parties acknowledge that as of the first acquisition date, **CRH Catering Co. Inc.** has acquired **Daniels Vending LLC** and all rights and obligations of Vendor under the Original Contract are transferred to and assumed by **CRH Catering Co. Inc.**

**2. Acknowledgment of Second Acquisition**

The parties acknowledge that as of the second acquisition date, **Sodexo Operations LLC.** has acquired **CRH Catering Co. Inc.** and all rights and obligations of Vendor under the Original Contract are transferred to and assumed by **Sodexo Operations LLC.**

**3. Continuation of Contract**

The Original Contract shall remain in full force and effect, except as amended by this Addendum. All terms, conditions, and obligations of the Original Contract shall continue to be binding upon the parties and their respective successors and assigns.

**4. Assignment of Rights and Obligations**

**Sodexo Operations LLC.** assumes all rights, duties, and obligations under the Original Contract as of the acquisition date, and all references to "Vendor" in the Original Contract shall be deemed to refer to **Sodexo Operations LLC.**

**5. No Change in Terms**

Except for the substitution of **Sodexo Operations LLC.** for **CRH Catering Co. Inc.** in accordance with this Addendum, the terms and conditions of the Original Contract remain unchanged and in full force and effect.

**6. Notice of Change**

All notices, communications, and payments under the Original Contract should now be directed to:

**7. Effective Date**

This Addendum shall become effective as of the date this Addendum is signed by both parties.

This Addendum may be executed in counterparts and transmitted electronically, each of which shall be deemed an original and all of which shall constitute one and the same instrument.
