# WHY THE TWIN CITIES

If you ask anyone from the Twin Cities, they will, very politely, tell you that it's one of the best places to live in the entire country. Despite the fact that the normal daily temperature in January is only 12 °F, both Minneapolis and St. Paul have been steadily growing for the last decade, and the region's overall population has nearly doubled since 1970. Their cost of living is 10% lower than it is in the Baltimore metro, and they are home to 14 Fortune 500 headquarters. On top of their economic success, the Twin Cities are one of just 13 metros with a MLB, NBA, NFL and NHL franchise and the region has the one of nation's most vibrant theater scenes outside of New York and Chicago.

Over the next few days, we will learn that this success did not come about by accident. The Twin Cities have a history of regional cooperation, forward thinking investment and innovative policies that have set the stage for their success. The latest, and perhaps most ambitious, example is the Groundbreak Coalition, a joint effort of the region's largest corporations, foundations and anchor institutions centered on a \$2 billion investment strategy.

We'll learn more about the Twin Cities' unique approach to regionalism with the Metropolitan Council, a policy-making body, planning agency, and service provider that partners with local governments by managing transit, water systems, parks, and housing programs.

Culturally, the Twin Cities are an unlikely melting pot. The region is home to a large and diverse Native American community, as well as descendants of French and northern European settlers, Mexican-Americans with century-old roots, and most recently, refugees from southeast Asia and Somalia. We'll learn how each of these cultures has left their mark on life in MInneapolis and St. Paul.

The region is certainly not without its challenges and we'll have the opportunity to hear from Twin Cities leaders about their successes and setbacks in tackling issues ranging from divisive infrastructure to climate change to their own legacy of redlining and segregation.

# TIMELINE

8,000 BCE

The Dakota name the falls at the confluence of Mni Sota Wakpa (Minnesota) 1680

Fr. Louis Hennepin visits the falls and Haha Wakpa (Mississippi). The Dakota refer to the falls as Owamniyomni. 1823

Colonol Josia Snelling oversees the construction of Fort Snelling and the first mills at the falls. 1805

Zebediah Pike purchases two tracts of land from the Dakota located on the St. Croix, Mississippi and Minnesota rivers for \$2,000. These lands would become the Twin cities.

1976

The Twin Cities begin welcoming Hmong refugees from Southeast Asia. The Hmong communty now makes up more than 10% of St. Paul's population. 1968

Dedication of I-94, which was built through Black and working class neighborhoods, including St. Paul's Rondo community. One in eight African Americans in St. Paul lost a home to I-94. 1965

Poppin Fresh, the Pillsbury Doughboy is born 1947

Minneapolis Mayor Hubert Humphrey establishes the city's first civil rights commission one year before being elected to the US Senate.

1983

District Energy opens in St. Paul and begins providing heat to the business district. In 1993 the plant would begin to provide chilled air as well. 1984

Purple Rain is released. The film would produce two #1 hits, win an Oscar for best soundtrack and introduce America to the purifying waters of Lake Minetonka. 1990s

Somali refugees begin moving to the Twin Cities after the start of the civil war. The Twin Cities is now believed to be home to the largest Somali populaiton outside of East Africa, with over 80,000 residents. 2007

The I-35W bridge over the Mississippi river collapses during rush hour, sparking nationwide concern regarding the safety of the country's infrastructure.

1838

The community of Pigs Eye is founded by Whiskey Distellers forced to move away from Ft. Snelling. Pigs Eye is later renamed St. Paul by Fr. Lucien Galtier.

1848-1910

Minneapolis is a national leader in lumber production 1858

Minnesota becomes a state, with St. Paul named the capital. The same year, Minneapolis is incorporated as a city. 1860

Eliza Winston, an ensaved Missisippi woman who travelled to St. Anthony with her enslavers for the summer, filed a lawuit and won her freedom in a Minneapolis court.

1928

Washburn-Crosby merged with four other flour mills, and General Mills was born.

1922

Charles Schulz, the creator of the Peanuts. is born in Minneapolis. Much of Peanuts was based on his formative years in the Twin Cities. 1882

Upton Island Station produces the first centralized hydroelectric power in the United States. The station would help lead Minneapolis' move from gas to electric power.

1866 -

The Washburn-Crosby and Pillsbury companies were founded in Minneapolis with mills on the MIssissippi River. For the next half century, the Twin Cities would be a global leader in grain production.

2013

On December 9, the final 2:07 of the the Vikings/Ravens game saw 36 total points, 5 lead changes, and a 29-26 Ravens victory.

2014

The Central Corridor Lightrail Line (or Green Line) opens. The line connects St. Paul and Minneapolis and is currently being expanded into suburban communities.

2020

The murder of George Floyd in Minneapolis sparks a global protest movement against racial injustice, the largest since the Civil Rights movement of the 1960s,

2023

The Minnesota state legisature passes omnibus \$1.3B transportation package including a 3/4 cent regional transportation sales tax expected to raise \$440M annually for transit.

### Employment by Industry








Our trip will begin at the Mill City Museum. Built into the ruins of what was once the world's largest flour mill, Mill City Museum is located on the historic Mississippi Riverfront. The museum opened in 2003 and focuses on the founding and growth of Minneapolis. The museum led a wave of redevelopment in the early 21st century that reshaped East Town Minneapolis - an area made up by the neighborhoods of the Mill District, Downtown East, and Elliott Park. At the museum we will be welcomed by Minneapolis Mayor Jacob Frey and a panel of leaders from the business and philanthropic communities.



### **Jacob Frey**

Mayor, City of Minneapolis

Jacob Frey grew up in northern Virginia and first visited Minneapolis to run the Twin Cities Marathon while in law school at Villanova University in Philadelphia. He successfully ran to represent the Third Ward on the city council in 2013, and was elected Mayor of Minneapolis in 2017. As Mayor, Frey has championed an agenda centered on increasing access to affordable housing throughout the city, strengthening community-police relations, and fueling economic growth through inclusive policies. To help bridge the city's racial disparities, Frey worked with his Council Colleagues to establish Cultural Districts, areas prioritized for investment, and created a first-of-its-kind Commercial Property Development Fund to target resources to neighborhoods that have historically experienced disinvestment.



### Peter Frosch

Chief Executive Officer, Greater MSP

As CEO of Greater MSP, Peter Frosch leads global strategy for economic development and job creation for the 15-county Minneapolis-St. Paul region. As a partnership of over 350 businesses, universities, cities, counties, foundations and nonprofit organizations, GREATER MSP advances inclusive economic growth and global competitiveness by executing strategies in the areas of job creation, talent, innovation and capital. Frosch served as Senior Vice President of Strategy at GREATER MSP before taking on the role of CEO in 2019. Before joining GREATER MSP in 2013, Frosch served as Legislative Director for Congresswoman Betty McCollum in Washington, D.C., and as Director of Environmental Policy at Environmental Initiative, a Minneapolis-based nonprofit.



### **Adair Mosley**

Chief Executive Officer, African American Leadership Forum

Adair Mosley joined AALF after a distinguished tenure as president and CEO of Pillsbury United Communities. Adair is recognized as a passionate change-maker and relentless strategic innovator who has demonstrated radical and inclusive solutions to the community's most urgent needs. In 2020 he launched Justice Built Communities, an equitable economic development corporation to prevent gentrification while prioritizing wealth creation in black and brown communities, securing \$5M for its launch. One of his career highlights was securing \$1M in scholarship funds for the graduating class of 2022 at North High School, Minneapolis. Adair serves on the boards of the Women's Foundation of MN and MinnPost, the Community Advisory Board for the Federal Reserve Bank of Minneapolis and as a Regional Champion for the Groundreak Coalition.



### Peter McLaughlin

Executive Director, LISC Twin Cities

Peter McLaughlin joined LISC as Executive Director in 2019. He previously served 28 years on the county board and while representing South and Southeast Minneapolis, McLaughlin helped lead a range of important efforts, including expansion of the region's transit network, transit-oriented development along emerging light rail lines and community reinvestment programs that spurred new businesses and jobs. His work on multiple community partnerships in the Phillips and Cedar-Riverside Neighborhoods and along the Midtown Greenway were a signature part of his work. McLaughlin also spent six years as a state representative, leading passage of the Neighborhood Revitalization Program, authoring Minnesota's first parental leave law, working closely with the Jobs Now Coalition and advocating for progressive tax policies, including those that helped support affordable housing.




### **Sean Sherman**

Chef Sean and Owamni team work to make indigenous foods more accessible to as many communities as possible. This includes prioritizing the purchase of ingredients from Indigenous food producers. Chef Sean has removed colonial ingredients such as wheat flour, cane sugar and dairy and is proud to present a decolonized dining experience. Chef Sean is the author of the widely acclaimed The Sioux Chef's Indigenous Kitchen, winner of the 2018 James Beard Award for Best American Cookbook. He is also the co-founder of North American Traditional Indigenous Food Systems (NATIFS), a nonprofit dedicated to addressing the economic and health crises affecting Native communities by re-establishing Native foodways, and the Indigenous Food Lab restaurant, training, development and support center located in Minneapolis.

### **Heather Worthington**

Managing Consultant, Center for Economic Inclusion

Heather Worthington joined the Center with more than 25 years of leadership experience in local government organizations, most recently as the founder and Principal Consultant with Worthington Advisors LLC, a consultancy focused on governance and policy advising, leadership and team building and land use strategy guidance, all through a racial equity lens. As Managing Consultant, Worthington leads efforts to accelerate racial equity and regional inclusive economic growth through systems-change initiatives with local, regional and state government agencies. As Director of Long Range Planning in Minneapolis, Worthington led the creation, engagement and policy adoption of the Minneapolis 2040 Comprehensive Plan. Worthington is an Adjunct Faculty in the Hamline University School of Business, and currently serves as Chair of the Midway Investment Cooperative and as a Trustee for the Episcopal Church of Minnesota.



### Isaac Russell

Director of Public Policy, Center for Economic Inclusion

As Director of Public Policy for the Center for Economic Inclusion, Isaac Russell develops and leads strategies to close racial wealth gaps and catalyze an inclusive equitable economy. He builds the internal capacity of the Center's team to influence local, regional and statewide public policy, and leverage external coalitions and partnerships to the same end. Prior to joining the Center, Russell served as a Legislative Assistant in the Minnesota State Senate from 2013 to 2022. Prior to his legislative career, Russell learned about the challenges small businesses face during his tenure as a project manager for an industrial flooring company.

He currently serves on the board of trustees of the Science Museum of Minnesota, the board of directors of the St. Paul Downtown Alliance and the Corporate Council for Metropolitan State University, and has been a fellow of the University of Minnesota's Institute on the Environment since 2016.



### **Jenae Batt**

As Director of Marketing and Public Relations for Ever-Green Energy and its parent company District Energy St. Paul, Jenae Batt works across utility operations to develop meaningful customer engagement and coordinate a variety of projects targeted to communicate the value of energy services, bolster customer loyalty and support utility system growth. She leads a team in implementing communications strategies targeting audiences on a spectrum of technical acuity, from the public to industry experts. Prior to joining Ever-Green Energy, Jenae worked in communications and donor relations at University of Minnesota Medical School, and earned a Master's in English literature at Boston College.

As President and CEO of the St. Paul Area Chamber, B Kyle champions a diverse business community to create an economically vibrant, inclusive and globally competitive region. Prior to her work at the Chamber, she spent 11 years at the St. Paul Port Authority, ultimately co-leading its development work in St. Paul on projects such as the Treasure Island Center, CHS Field, the St. Paul Police Department's Public Safety Training Facility and Major League Soccer. A veteran of the U.S. Army, Kyle is leading the chamber into a new chapter of growth and transition, and was recognized by the Minneapolis St. Paul Business Journal as one of the top 10 Most Admired CEOs in 2020.



### **Todd Hurley**

Executive Director, St. Paul Port Authority

St. Paul Port Authority Executive Director Todd Hurley grew up in St. Paul and worked for the city for more than 30 years, including as director of the Office of Financial Services, where he lead negotiations with developers, contractors and landowners for the Xcel Energy Center, CHS Field, Allianz Field and other key projects. After joining the Port Authority in 2019 as chief financial officer, he was elevated in 2022 to lead the agency, which manages four port facilities along the Mississippi River in St. Paul, as well as a number of inland business centers and other community development initiatives in the city.

### MIDTOWN GREENWAY / MIDTOWN GLOBAL MARKET Sponsored by Loyola University Maryland

The Midtown Greenway is a 5.5-mile long former railroad corridor in south Minneapolis with bicycling and walking trails. The Midtown Greenway Coalition is the grassroots organization that successfully advocated for installation of the Midtown Greenway by public agencies. The Coalition continues to engage our community in protecting, improving, and using the Greenway. Located just off the Greenway, is the Midtown Global Market. Owned by two non-profit entities: the Cultural Wellness Center and the Neighborhood Development Center, the Market serves as a small business incubator whose mission is to provide access and opportunity for aspiring entrepreneurs.





### Soren Jensen

Executive Director, Midtown Greenway Coalition

Soren Jensen has served as Executive Director of the Midtown Greenway Coalition, a grassroots organization that advocated for the installation of a 5.5-mile shared-use trail network along a former railroad corridor in south Minneapolis, since 2011. Prior to taking on the role, Jensen had more than 20 years of experience in the non-profit sector, including management positions with the National Parks Conservation Association, the United Way, American Heart Association, Target Corporation, and the American Red Cross. He's a former board member of the Corporate Volunteerism Council – Twin Cities and a founding board member of the Minnesota Association for Volunteer Administration (MAVA), and served on the board of volunteerism nonprofit HandsOn Twin Cities for seven years.



### **Eduardo Barrera**

Real Estate Development Manager, Neighborhood Development Center

As the Real Estate Development Manager for the Neighborhood Development Center, Eduardo Barrera works with community partners to restore properties into dynamic commercial spaces in which small businesses can grow. Originally from Mexico City, Barrera has two decades of experience with nonprofits and state and local governments in Minnesota and California focused on delivering affordable housing and economic development to underserved communities. He earned a degree in Public Affairs with a concentration in Housing, Economic and Community Development from the University of Minnesota Hubert H. Humphrey School of Public Affairs, and served on the City of Saint Paul Planning Commission.

### **RONDO NEIGHBORHOOD**

### Sponsored by University of Maryland, Baltimore

The Rondo Neighborhood was the center of the Black community in the Twin Cities for much of the 20th century and was, at one time, home to 80% of St. Paul's African American population. During the construction of I-94 from 1956 through 1968, 700 family homes were demolished, 300 businesses were closed or torn down and the neighborhood was split in two by the highway. In recent years, the Rondo community has developed a vision to reconnect the community by constructing a land bridge and creating a new cultural district.



### **Keith Baker**

Executive Director, Reconnect Rondo

As executive director for Reconnect Rondo, Keith Baker leads the organization's mission to revitalize the Rondo Community with a land bridge that reconnects Rondo and creates Minnesota's first African American cultural enterprise district. Keith has more than 35 years of experience in the public, private and nonprofit sectors. His 18 years with the Minnesota Department of Transportation included oversight of federal and state professional technical contract administration and construction compliance monitoring. He served as a member of the Ramsey County Blue Ribbon Commission, which helped elevate Minnesota's ranking as 50th in the nation for racial disparities. He also helped lead an effort to ensure equitable inclusion of minority- and women-owned engineering and architectural firms on the billion dollar U.S. Bank Stadium project.



### **Marvin Roger Anderson**

Board Chair, ReConnect Rondo

Marvin Roger Anderson has long been a key leader of efforts to celebrate the past, present and future of St. Paul's African American community of Rondo. He co-founded the Rondo Days Festival in 1983 and was instrumental in creating the Rondo Commemorative Plaza in 2018. Anderson currently serves as board chair for ReConnect Rondo and the Rondo Center of Diverse Expression, was co-founder and first president of the Minnesota Association of Black Lawyers and chaired the Archie Givens Collection of African American Literature at the University of Minnesota. He now helps lead the restorative movement to revitalize Rondo with an African American cultural enterprise district connected by a land bridge.

### **DOWNTOWN EAST TOD**

### Sponsored by Margrave strategies

Downtown East has been the home of significant redevelopment in the 21st century. Initially spurred by the construction of the Mill City Museum and the Guthrie Theater, the neighborhood has more recently seen the development of US Bank Stadium and the Wells Fargo & Co.'s East Town Towers. Downtown East's transit oriented blend of commercial, residential and entertainment focused development has made it a national model for urban renewal.

The project included two anchor offices, a hotel, apartments, new green space and a parking ramp to serve both the office buildings and the adjacent US Bank Stadium.

Michael Vekich has chaired the Minnesota Sports Facilities Authority, the governing board that represents the state's ownership and oversight of the U.S. Bank Stadium, since 2017. Also known as Minnesota's 'go-to guy,' Vekich consistently demonstrates expertise in strategic planning, finance, compliance, governance, succession planning and resource alignment. He serves as chair of the Minnesota State Colleges and Universities Board of Trustees and BNC National Bank, as well as CEO of accounting firm Vekich Chartered. He previously served as President/Chair of the Bank Holding Company Association, and twice as the Acting Director of the Minnesota Lottery and Chair of the Minnesota Board of Accountancy. Vekich earned his degree from the University of Minnesota.

The franchise was named American Association Organization of the year from 2015 through 2018, and most recently in 2019, with Sharrer having been recognized as the league's Executive of the Year in each of those years. Derek played a significant role in the Saints effort to build support for, secure funding for, and finally to design, construct, market, and operate the award-winning ballpark in Lowertown, St. Paul...CHS Field. He was also instrumental in the team's transition from Independent to Affiliated baseball as the Saints entered into a partnership with the Minnesota Twins making them their Triple-A affiliate.

The team takes pride in being a socially responsible restaurant that weaves together business with community and culture. All dishes are made fresh and prepared Halal.

### **Center for Economic Inclusion**

Founded in 2017, the Center for Economic Inclusion is the nation's first Black-woman founded and led organization dedicated exclusively to strengthening public- and privatesector civic infrastructures and collective capacity to disrupt systems and influence market forces while advancing an inclusive economy. The Center equips public- and private-sector leaders and employers with the knowledge and tools to build, scale and institutionalize anti-racist workplaces in shared accountability with Black and Brown people to close racial wealth gaps and build racially equitable and inclusive regional economies.

### City of St. Louis Park

St. Louis Park is a first-ring suburb located immediately west of Minneapolis, with just under 49,000 residents in 10.8 square miles. Numerous trails connect the city to parks, downtown Minneapolis and other nearby communities. With a sound economic base, a healthy mix of new and traditional housing, and a nationally renowned school district, new development in St. Louis Park primarily takes the form of infill development and redevelopment in key areas of the community. The city's objective for the three station areas included in the METRO Green Line Extension has been to foster and facilitate transit-supportive redevelopment using transit-oriented development best practices and planning principles.

### **CHS Field**

CHS Field is a baseball park in downtown St. Paul, home to the St. Paul Saints, the AAA affiliate of the Minnesota Twins, as well as Hamline University's baseball team. Located in the historic Lowertown District, the park is built on the former site of a long-vacant industrial-use facility. Environmentally friendly features include 300 solar panels generating about 12 percent of the park's energy and a 27,000-gallon rainwater collector. The park is connected to the Bruce Vento Trail, and biking is encouraged.

Ever-Green Energy, a subsidiary of the nonprofit District Energy St. Paul, provides heating and cooling services to downtown St. Paul. Ever-Green Energy is a green energy provider, and its primary fuel is a renewable, local resource: clean, urban wood waste. The system is the largest hot water district system in North America and an industry leader in system integration featuring biomassfired cogeneration, thermal storage and solar thermal technology. Ever-Green Energy has been recognized by the United Nations Environment Programme for serving as an international model for best practices.

### **Downtown East, Minneapolis**

Downtown East offers easy access to a wide variety of popular dining and entertainment destinations. But the area had long been overlooked, resulting in a sea of surface lots and underutilized real estate. Completed in 2016, a \$588 million, five-block redevelopment project reshaped the Minneapolis urban landscape by bridging the central downtown area to U.S. Bank Stadium ( Home of the Minnesota Vikings), the University of Minnesota, the Mill District and the Elliot Park neighborhood. The project included 1.2 million square feet of office space in two 17-story towers, multi-tenant Millwright building, a 200-unit residential complex, a 4.2 acre public greenspace, a hotel, four sky bridges, a six-level parking ramp and 26,000 square feet of retail space.

But the Market is more than just a food hall - it's a community supporting food and drink innovation, an incubator empowering chefs and a space to house the diverse flavors and experiences of the region.

### **Metropolitan Council**

Owned by two non-profit entities: the Cultural Wellness Center and the Neighborhood Development Center, the Market serves as a small business incubator whose mission is to provide access and opportunity for aspiring entrepreneurs. Together these entities make up a dynamic community gathering place that highlights and promotes the economic, social and cultural assets of Minnesota and celebrates the healthy foods, arts, crafts and other aspects of the region's diverse heritage. The market is home to over 50 vendors including diverse restaurants, specialty grocery items, and locally made crafts and goods. Over 1.5 million people visit the market every year.

### **Midtown Greenway**

The Midtown Greenway is a 5.5-mile long former railroad corridor in south Minneapolis owned by the Hennepin County Regional Railroad Authority with bicycling and walking trails maintained by the City of Minneapolis. The Midtown Greenway Coalition, the grassroots organization that advocated for installation of the Midtown Greenway, continues to engage the community in protecting, improving and using the Greenway. The trails are plowed in winter, lit at night and open 24/7, with thousands of daily users in temperate weather and hundreds even in winter.

### Mill City Museum

Mill City Museum was built within the ruins of the Washburn A Mill, the flagship mill of the Washburn-Crosby Co. (later General Mills) and the largest and most technologically advanced flour mill in the world on its completion in 1880. Mill City Museum is an adventure for the senses. See 19th-century flour milling machines, trace the journey of wheat from farm to market and learn about how wheat milled in Minnesota affected what people eat around the world.

### Owamni by the Sioux Chef

Owamni is the first locally Indigenous restaurant in a major U.S. city, offering a 'decolonized' dining experience that's Dakota inspired and on Dakota land. James Beard Award-winning Chef Sean Sherman, Oglala Lakota, founded the catering and food education business The Sioux Chef and works to make indigenous foods more accessible through Owamni and other ventures including the North American Traditional Indigenous Food Systems (NATIFS) nonprofit and the Indigenous Food Lab in Midtown Global Market.

### Reconnect Rondo

Reconnect Rondo advocates to create Minnesota's first African American cultural enterprise district connected by a community land bridge, helping to repair, restore and revitalize St. Paul's Rondo neighborhood, which was shattered with the 1956-1968 construction of Interstate 94. The Rondo land bridge would cap Interstate 94 for several blocks, making up for the loss of over 700 homes and 300 businesses. The group's vision is to become an admired national model for equitable development success, known for leading a restorative movement in Minnesota.

### Rondo Neighborhood, St. Paul

Rondo was the heart of St. Paul's African American community, housing the majority of African American residents in the city and numerous businesses, organizations and institutions. In the late 1950s, construction of Interstate 94 connecting downtown Minneapolis and St. Paul shattered this community. Opponents suggested an alternative route along the railroad north of the neighborhood, but officials cited efficiency in approving the route that split Rondo and forced the relocation of hundreds of people. This history informed construction of Metro's Green Line light rail service, which opened in 2014. In February of this year, Rondo was awarded a \$2m Reconnecting Communities grant to fund planning, studies and analysis as part of the land bridge's master plan. This move is helping to fuel optimism that a growing portion of the land bridge and surrounding economic development may well be supported by federal funding.

Established by the Minnesota legislature in 1929 as a non-profit governmental agency to manage the St. Paul Harbor, the St. Paul Port Authority now owns and operates four port facilities along the Mississippi River in St. Paul. As the nation's 13th largest inland port by tonnage, the St. Paul Harbor provides critical links to Minnesota's rail and roadway freight networks. The St. Paul Port Authority also developed a number of inland business centers, many on land restored from pollution, which are home to some 500 companies.

### **U.S. Bank Stadium**

U.S. Bank Stadium is a state-of-the-art, multi-purpose facility and home of the NFL's Minnesota Vikings. This architectural landmark features a striking silhouette, five large glass pivoting doors, and zinc metal exterior panels. The translucent ETFE roof was the first of its kind in NFL stadiums. Following a groundbreaking ceremony on December 3, 2013, the stadium was built in two-anda-half years and completed six weeks early. The project achieved unparalleled local workforce and business participation that far exceeded the goals for the project. Furthermore, the project spurred \$1 billion in surrounding development, including 1.2 million square feet of office space, 28,000 square feet of retail, approximately 400 residential units, and a 4.2-acre green space.

### **West Indies Soul Food**

Growing up surrounded by multicultural Caribbean character and the homegrown calypso soundtrack of the West Indies, Sharon Richard-Noel moved to friendly Minnesota in 1982.
